- Radiological TTX/Functional Exercise updates | The exercise was well received and was successful. Partners expressed appreciation for the new format, stating it was easier for them to seek out answers to injects and questions throughout the exercise, rather than pulling people to the table and away from their work for the day. When possible, we will implement this style of exercise more often.

#### 2:50 pm | Facility Updates | 20 min

- Medical Director | Dr. Kal Attie- MCA rep poll: state rescinding pandemic emergency protocols May 11, some facilities have changed in house masking requirements. MCAs doing anything different? Waiting until May 11<sup>th</sup>?
  - Heidi- they rescinded the one protocol right away, went back to other pre-established protocols.
     1405- rescinded.
  - O COVID reporting requirements- LTC on May 11<sup>th</sup>- ending at state level, only direct reporting into NHSN. Hospital reporting- will continue in EMResource. NHSN is changing their cadence. Hospitals will still have to do daily reporting, or they can use the API for automated reporting. Email Amanda or Damon for more information about the API and how to get started.
- DEPR BETP | Representative- COVID numbers are very low compared to what they have been historically. Pediatric hospitalizations very low (7 confirmed, 2 ICU). Confirmed ED visits 6%. Flu numbers looking very good. Ped Hospital capabilities- PICU Available is really good. Overall doing well into summer.
- Epidemiology | Roger Racine- COVID numbers continue to decrease, avg around 400 cases per day, tracking the newer variants. Increase in testing, identified outbreaks are at an all time low. Mandatory reporting of negative flu tests will cease for Rogers office. Will continue to have daily data from hospitals for COVID. R7 only had 221 new cases over the last 2 weeks, decrease of over 40%. Very low COVID levels in R7. // R8 respiratory fungal infection outbreak, over 100 cases, investigation headed by MIOSHA. Blastomycosis (?)
