Reminder: Open Enrollment Opportunity for Recurring COVID-19 Testing Supply Allocation (for facilities not already enrolled)

The Michigan Department of Health and Human Services (MDHHS) is reminding Long-Term Care Facilities that open enrollment for recurring testing supply allocation will occur Monday, March 6 through Friday, March 10, 2023.

Facilities that are not currently enrolled to receive recurring shipment of COVID-19 tests from MDHHS and wish to do so, should fill out the following form by **March 10, 2023 to initiate recurring shipments:**

[LTCF Monthly Antigen Shipment Enrollment form](#)

This monthly recurring allocation of tests will replace the current ordering process, where facilities request testing supplies using the online Test and Support Form each time supplies are needed.

Sites do not need to sign up for auto-shipments more than once. MDHHS will provide quarterly opportunities for sites to adjust allocations or opt-out of the auto-shipment process. If you already submitted the Monthly Antigen Shipment Enrollment form AND were contacted by MDHHS regarding enrollment, there is no need to submit again.

Quarterly Enrollment Opportunity: Each quarter MDHHS will re-open this enrollment survey for those sites that either missed the initial sign-up deadline or are newly established. The quarterly enrollment opportunity will be open for the 1st full week of each new quarter; the schedule for the next open enrollment period is provided below:

June 5th-9th

Facilities will receive additional information prior to the start of auto-shipment. Facilities may still use the [online ordering form](#) for a contingency supply to be provided to them until the next month's shipment.

Ebola Checklist for Health Care Facilities

From the emergency room to the clinic, frontline health care facilities are the first line of defense against the spread of disease. All health care facilities need to be prepared to care for patients with Ebola, or another viral hemorrhagic fever (VHF), and to prevent transmission to staff, other patients, and within our

communities. The [Health Care Facility Special Pathogens Checklist](#) is a planning tool for health care facilities to assess their readiness to identify, isolate, inform, and provide initial treatment for patients suspected or confirmed to be infected with a viral hemorrhagic fever. It guides facilities through a review of their immediate care capabilities and links to resources that will help improve or fill gaps in preparedness.

CDP NETEC Healthcare Provider Down microlearning video

The Center for Domestic Preparedness (CDP) is now partnering with the National Emerging Special Pathogens Training and Education Center (NETEC) to produce its Healthcare Provider Down microlearning video.

The NETEC establishes standards for special pathogen preparedness and response in health systems across the U.S.

The offering, which will be released later this year, will show medical responders how to safely evacuate a fellow provider who becomes incapacitated while treating a patient with an infectious disease.

The CDP's microlearning videos, which are less than 10 minutes in length, allow responders to learn about a variety of healthcare, hazardous materials, and law enforcement matters. Offerings currently available cover topics such as mass casualty incident planning, fentanyl incident response, hazardous materials identification, and grounding and bonding procedures.

Its suggested operational structures and tasks can be modified or refined according to an organization's size, resources, complexity and capabilities. It represents the best collective thinking of private-sector cybersecurity and emergency management executives of the HSCC Incident Response/Business Continuity (IRBC) Task Group of the Health Sector Coordinating Council's Cybersecurity Working Group (CWG). It is not associated in any way with any regulatory compliance program.

Cisco has addressed a critical security vulnerability found in the Web UI of multiple IP Phone models that unauthenticated and remote attackers can exploit in remote code execution (RCE) attacks. The RCE flaw (CVE-2023-20078) allows attackers to inject arbitrary commands that will be executed with root privileges following successful exploitation. A successful exploit could allow the attacker to execute arbitrary commands on the underlying operating system of an affected device. The list of affected devices includes Cisco IP Phone 6800, 7800, and 8800 series devices with Multiplatform Firmware (vulnerable to both RCE and DoS attacks), and the Unified IP Conference Phone 8831, Unified IP Conference Phone 8831 with Multiplatform Firmware, and Unified IP Phone 7900 Series (only vulnerable to DoS attacks).

While Cisco released security updates to address the CVE-2023-20078 RCE vulnerability, the company said it would not release patches to fix the CVE-2023-20079 DoS flaw. Cisco also announced in December that it [would release patches for a high-severity zero-day vulnerability](#) (CVE-2022-20968) with public exploit code found in the Cisco Discovery Protocol (CDP) processing feature of Cisco IP Phones running 7800 and 8800 Series firmware. FBI and CISA Release #StopRansomWare: Royal Ransomware

The Federal Bureau of Investigation (FBI) and the Cybersecurity and Infrastructure Security Agency (CISA) released joint Cybersecurity Advisory (CSA) [#StopRansomWare: Royal Ransomware](#) to provide network defenders tactics, techniques, and procedures (TTPs) and indicators of compromise (IOCs) associated with Royal ransomware variants. FBI investigations identified these TTPs and IOCs as recently as January 2023.

Royal ransomware attacks have spread across numerous [critical infrastructure sectors](#) including, but not limited to, manufacturing, communications, healthcare and public healthcare (HPH), and education.

CISA encourages network defenders to review the CSA and to apply the included mitigations. See [StopRansomware.gov](https://stopransomware.gov) for additional guidance on ransomware protection, detection, and response.

Situation Report and Clinician's Reference Guide to Marburg Virus Disease

Equatorial Guinea reported its first outbreak of Marburg virus disease (MVD). The outbreak is in the Kié-Ntem region, which borders Cameroon and Gabon, in the north of Equatorial Guinea. Nine people with symptoms consistent with MVD have died, and one tested positive for the virus. An additional 16 suspected cases are being investigated. Reports of Marburg virus disease (MVD) outbreaks in [Equatorial Guinea in February](#) and in [Ghana last August](#) are just the latest in the 50-year history of this deadly viral hemorrhagic fever. Beginning with the first reports of infection in laboratory workers in 1967, MVD has re-emerged repeatedly. Yet there are no medical countermeasures (e.g., vaccines or therapeutics) licensed to fight MVD, which has a case fatality of up to 88 percent.

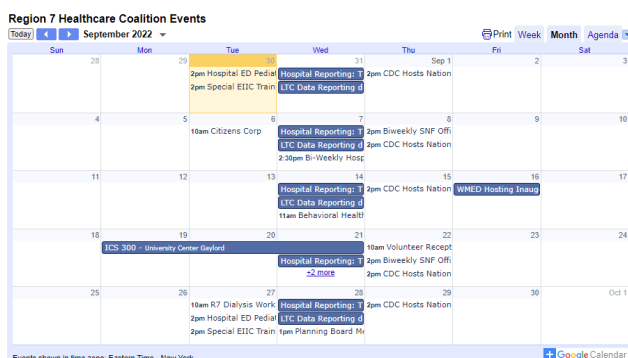
